

ORANGE COUNTY COUNCIL 2010 NATIONAL SCOUT JAMBOREE CONTINGENT FEES POLICY

Each reservation and application must be accompanied by a non-refundable \$300.00 deposit. Priority of troop assignments will be based on the date of receipt (at the Council Service Center) of your registration. A payment reminder will be sent to you each month. You must meet the minimum payment amounts listed below to secure your position in the Jamboree contingent. If you fall behind the minimum payment schedule, your troop slot may be given to another Scout.

❖ Note: Founders Award discounts do not apply for the Jamboree.

REFUND POLICY:

The following is a schedule of dates for refunds if you find yourself unable to go. Remember that the initial \$300 registration deposit is non-refundable. All other monies paid toward the Jamboree contingent fee at the Scout Office are refundable except as noted in the schedule below. These dates are based on commitments for such things as Jamboree registration to BSA, airfare, tours, buses, hotels, restaurants, patches and troop equipment.

June 1, 2009	\$1,200 Total not refunded starting this date. (includes deposit) 40% Fee
Sept. 1, 2009	\$2,000 Total not refunded starting this date. 60% Fee
Dec. 1, 2009	\$2,250 Total not refunded starting this date. 70% Fee
Feb. 1, 2010	\$2,750 Total not refunded starting this date. 85% Fee
Apr. 1, 2010	\$3,300 Total not refunded starting this date. 100% Fee

*****NOTE*****

If for some reason you are not able to go, there is one other way to get a refund!!! You will receive a full refund, less the \$300 registration deposit that is **non-refundable** – if you recruit a Scout to go in your place, that Scout registers at the Scout Office before March 1, 2010, and if the contingent is full when it leaves for the Jamboree. The new Scout must bring the Jamboree contingent fee up to date as of the date the coupon in the minimum payment schedule calls for and make that payment to the Scout Office. The Scout Office will refund the money to you after the contingent returns from the Jamboree and the Council Jamboree Budget Committee approves the refund.
